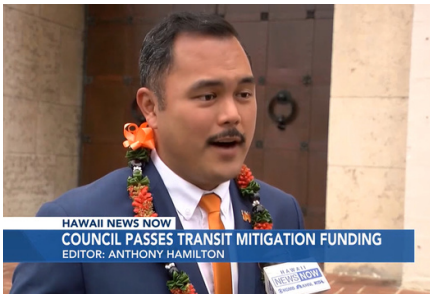

City Council Moving Forward with the Transit Construction Mitigation Fund



[Bill 40 \(23\)](#) Relates to the Transit Construction Mitigation Fund, specifically proposed to help Dillingham-area small businesses, on January 24, the Honolulu City Council voted 7-2 to adopt Bill 40, a measure aimed at providing financial assistance to eligible small businesses affected by ongoing rail-related construction along Dillingham Boulevard. The bill proposes a \$10,000 annual grant for qualifying businesses that opened before January 1, 2022, as long as active construction continues in the area. The measure will take effect on **July 1, 2024**, and applies only to small businesses majority-owned by residents, with 15 or fewer employees,

generating up to \$750,000 a year, and located within the same city block as the rail construction. The bill revives the city's long inactive transit construction mitigation fund, originally established in 2018.

Kalihi Town Hall with Rep. May Mizuno & Sen. Donna Mercado Kim



In January a joint community Town Hall was hosted by CM Dos Santos-Tam, newly appointed House Rep. May Mizuno, and Senator Donna Mercado Kim at Kalihi Uka Elementary School to discuss community concerns and upcoming legislative updates. Residents came together to address key concerns and outline potential actions for improvement. The discussions included traffic calming measures on Kalihi Street, particularly between Alejandro's & Nalanieha Street.



Our office will work with the Department of Transportation Services (DTS) to explore dedicated left turns at strategic intersections and address traffic flow challenges. Additionally, we discussed overgrowth concerns at specific locations, such as 1534 Kalaepaa lot and 3502 Kalihi Street near St. Anthony Retreat Center. Additionally, park lighting issues at Kalihi Uka Park and DeCorte Park were also on the agenda to help to deter illicit behavior and activities. As representatives of the community, we value your input, and these discussions contribute to our ongoing efforts to enhance our community. Our office will follow up with the City issues mentioned at the meeting. 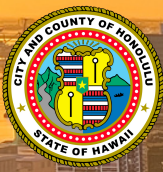

Bill 1 (2024) Raising the Purchasing Age of Herbal Cigarettes

[Bill 1 \(24\)](#) is sponsored by CM Dos Santos-Tam and CM Weyer, who is the Chair of Housing, Sustainability, and Health. Bill 1 aims to raise the age for herbal cigarette purchases to 21 to align with state statutes regulating tobacco products, set at 18 by the City Council in 2000, while acknowledging the potential health risks posed by various herbal cigarette varieties. Herbal cigarettes lack tobacco or nicotine, research suggests their dangers are comparable to conventional cigarettes. The legislation will be heard in the Housing, Sustainability, and Health Committee next.



Bill 3 (2024): Incentives for Construction of Affordable Rental Housing

The Honolulu City Council has passed [Bill 3 \(24\)](#), a first-reading measure aimed at providing private developers of affordable rental projects with increased financial incentives. Introduced by CM Dos Santos-Tam, the bill taps into an *existing* \$10 million grant from the city's general fund to support the construction of over 1,100 new homes in areas zoned for denser development. The move is seen as a response to market challenges and supports small developers facing higher interest rates, supply chain shortages, and increased material costs. Bill 3 builds on [Bill 7 \(19\)](#), offering an alternative incentive to developers in the form of a grant of up to \$35,000 per unit *before* construction begins, with varying amounts based on area median income or AMI. The proposed measure hopes to address the slow pace of development under Bill 7 and adapt to current market realities, supporting workforce housing for essential workers.

State & City Legislators Come Together to Continue Fentanyl Fight



CM Dos Santos-Tam participated in a press conference with Heather Lusk Executive Director of Hawaii Health & Harm Reduction Center (HHHC), Rep. Tam, and Rep Belatti, focused on the importance of opioid addiction prevention legislation. Two State House bills introduced by Representative Adrian Tam, [HB1669](#) and [HB2253](#) help to actualize this goal. Moreover, the 2021 historic multistate settlement agreements to address pharmaceutical companies' roles in the opioid crisis. Hawaii received multi-million dollars of funds from the settlements. The work of the Opioid Settlement Advisory Committee establishes procedures and plans on how to best reinvest the monies. A highlight of the meeting was in the total effort to reduce loss of life and provide resources to the people of Hawaii trapped in addiction. An understanding was made that public and private entities must collaborate to overcome bureaucratic obstacles in order to save lives.

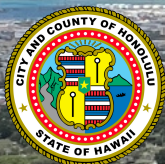

Recent Update on Mayor Wright Homes Construction



The construction of affordable for sale and rental housing at the Mayor Wright Homes on 521 North Kukui Street has been a massive project in the works for several years. The State of Hawaii, Hawaii Public Housing Authority, Highridge Costa, and Form Partners collaborated to make this effort possible. Last month, on January 22, a public hearing was held at Palama Settlement to update residents on the current and future plans of the construction. The attendees were presented with a detailed overview of the different phases of redevelopment, and were given the opportunity to ask questions to the entities involved. 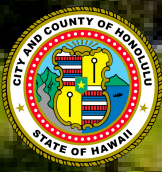
CM Dos Santos-Tam recently had the opportunity to tour the Nu'uuanu Reservoir with the staff from the Board of Water Supply. The tour stemmed from the Board of Water Supply's Draft Environmental Assessment (DEA) for the [Nu'uuanu Reservoir No. 1 Dam Improvements Project](#). The proposed action aims to align with the Department of Land & Natural Resources (DLNR) dam safety standards for Nu'uuanu Reservoir No. 1 and dam. Necessary enhancements for Nu'uuanu Reservoir No. 1, include constructing a new outlet works pipe structure, reconstructing embankments for slope and stability compliance, building a concrete spillway, installing monitoring instrumentation, and other updates. These measures are crucial for meeting the specified purpose and addressing the priority maintenance needs of the reservoir and dam. The project sustains the life of the reservoir and health of the dam. Public comments submitted by February 7, 2024 through email to EAKana@hbws.org.

Pauoa Stream Cleaning at the Start of the Year

Last month, the Department of Facility Management (DFM) cleaned and cleared out Pauoa Stream after a long time of inattention. Workers were able to remove trash, large discarded items, and debris. Many people in my district have emphasized the need to keep our streams clean. The brush and trash build-up after storms can lead to flooding in neighboring residents' homes. My office will keep working with the department to make sure these streams are receiving the proper stewardship.

Highlighting the International Union of Bricklayers and Allied Craftworks

On January 24, the Honolulu City Council expressed pride and appreciation for the commendable community service efforts of the International Union of Bricklayers and Allied Craftworkers, Local 1 of Hawai'i. Following the vandalism of nineteen gravestones at the historic Kawaiaha'o Church cemetery in November 2023, church member Brickwood Galuteria sought assistance from Mike Lovediro, Business Manager for Local 1. Volunteers from the union, who had previously assisted in restoration work, embarked on a challenging project to repair the vandalized gravestones, varying in weight from 150 to 800 pounds. The team, consisting of eight dedicated volunteers, meticulously cleaned, re-attached, and restored all 19 gravestones in a single day. The

Honolulu City formally recognizes and honors Local 1 for their compassionate and impactful contribution to the community.

2024 Braddahood Grindz Program Kickoff

CM Dos Santos-Tam participated in the kickoff for the 2024 Braddahood Grindz program, which is an initiative put together by the Hawaii Restaurant Association to support the UH Football Team and other sports at UH. The University of Hawaii football team has partnered with the Hawaii Restaurant Association (HRA) for a summer nutrition program called Braddahood Grindz. This initiative aims to provide meals to the team's players and staff throughout the summer. Four restaurants, including Giovanni Pastrami, Gytaku Hawaii, Kuhio Food Hall, and Ruby Tuesday Hawaii, will take turns offering one meal per week. The program, valued at over \$30,000, follows NCAA guidelines and involves Name, Image, and Likeness (NIL) Agreements with each UH football student-athlete. The HRA hopes to expand the program to other UH sports teams in the future.

Lōkahi World Music Festival

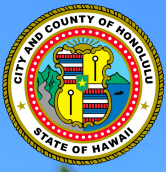

Honolulu City Council Votes to Approve Federal Agreement to Fund Skyline

Councilmembers voted last month by an 8-1 decision on a Resolution authorizing a federal agreement to fund the rail system's ongoing construction to the planned end point at Kakaako rail station by 2031. Additionally, on February 2, Mayor Rick Blangiardi signed an amended Full Funding Grant Agreement, unlocking \$744 million to complete Honolulu's rail system to Kakaako. The original 2012 deal provided over \$1.5 billion, but funding halted in 2017 due to concerns about rail building, planning, and management. The new agreement immediately releases \$125 million, with the remainder to follow in four phases. [U.S. Sen. Brian Schatz](#) lauded the move, emphasizing the collaboration between HART, the city, and federal and state partners. This is a significant milestone toward completing the initial phase of the Skyline project to the Civic Center station in Kakaako. 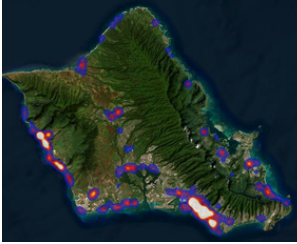

2024 Point In-Time Count Survey to Assess the Homelessness Population

Last month CM Dos Santos-Tam was able to participate in the 2024 Point In Time Count (PITC). Point-in-Time (PIT) counts are annual surveys conducted on a single night to gather data on individuals experiencing homelessness in a specific area. Volunteers lead these efforts, canvassing shelters, streets, and other locations, collecting demographic information such as age, gender, and veteran status comparable to the Census data. The collected data contributes to a national database and are reported to the U.S. Department of Housing and Urban Development (HUD). Local nonprofits and organizations collaborate to allow for this event to occur such as Hawaii Health & Harm Reduction Center (HHRC)

and Partners In Care. While PIT counts offer valuable insights into homelessness, the information obtained guides policy decisions, resource allocation, and targeted interventions to address homelessness. An issue affecting many men, women, and children through the State.

Various Public Housing Projects Across the Island Proceed

CM Dos Santos-Tam is passionate about expanding the affordable housing inventory on the island. There are a few public housing redevelopment projects that are underway that will help with the goal. These projects are rentals for low-income households on properties of the Hawaii Public Housing Authority (HPHA) including Mayor Wright Homes, Kuhio Park Terrance called Kuhio Homes, and Kuhio Park Terrance Low-Rise. Last month with approval the total development of the three projects will be \$892 mil. The project closest to beginning construction is the property of HPHA at 1002 North School Street. This project is slated to start in March. The details of these projects are the following; 1) School Street; homes 250; cost \$164 mil; completion 2026. 2) Kuhio Park; homes 304; cost \$182 mil; completion 2026. 3) Mayor Wright Homes; homes 911; cost \$546 mil; completion 2028.

2023 Honolulu Youth Commission Final Presentation

The 2023 Honolulu Youth Commission appointees included Diego Carranza, Puali'i Ann Zidek, Asa Shimizu, Kalena Shea, Kolten Soon, and Riley Mishina. All of these individuals represented the interests and passions of young people in each of the Council districts. The office represented were Councilmembers Weyer D2, Kiaaaina D3, Waters D4, Say D5, Okimoto D8, and our office. This experience and exposure to diverse perspectives and mutual commitment to service helps to create young leaders, that may one day take part in shaping the future of the city. Established in 2020 following the approval of [Resolution 19-329](#), the commission provides a platform for individuals aged 14 to 24 to actively engage in local government. The two-year term focused on youth representation and involvement in decision-making processes. CM Dos Santos-Tam was able to give a brief presentation to the group on the importance of civil service and the immense need for young, educated, enthusiastic people motivated to work for the City. 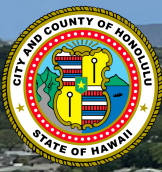
Sign up For Honolulu Authority for Rapid Transportation (HART) Updates

U.S. Navy Hosts In-Person Meeting on Red Hill Defueling Plans

The Navy held a virtual meeting to address the public's concerns about fuel removal at the Red Hill Bulk Fuel Storage Facility. The meeting took place on Wednesday, January 17, at 1 p.m. The event was hosted by Rear Admiral Marc Williams and Brigadier General Michelle Link. Additionally, this month a public meeting at Keehi Lagoon Memorial Hall on February 7 will offer updates on defueling, closure, and water monitoring. The Joint Task Force-Red Hill recently started removing residual fuel, with about 64,000 gallons remaining in low points of pipelines. The Navy Closure Task Force-Red Hill plans to complete this process in March, including the removal of 4,000 gallons of fuel and 28,000 gallons of sludge, and initiate environmental remediation efforts. The Ala Moana Boulevard Elevated Pedestrian Walkway, a State of Hawaii Department of Transportation initiative, is progressing until June 2024.
