

Council Bill Search

It's been nearly two months since the devastating wildfires in Lahaina, and the destruction and loss of life are still difficult to fathom. The recent events on Maui and the wildfires in our own neighborhoods have underscored the urgent need for comprehensive emergency preparedness. We owe it to our communities throughout the City and County of Honolulu to be proactive and prepared.

On September 29th, I introduced an Emergency Preparedness Legislative Package. This package is not only about responding to disasters; it's about anticipating them and ensuring our community's safety and resilience. The package includes three separate measures:

- **RES 23-239**, co-introduced with Council Chair Tommy Waters, would initiate a charter amendment to add certain minimum qualifications for the Director of Emergency Management.
- **RES 23-240**, co-introduced with Budget Chair Radiant Cordero, requests the City Administration to annually present budget recommendations that address long-term emergency preparedness.
- **RES 23-241**, co-introduced with Public Safety Chair Val Aquino Okimoto, urges the City Administration to establish a working group to provide recommendations on long-term emergency preparedness within the context of residential housing.
